Contest Rules

1. The Contest is open for **new MT4 Trading Account** with LIRUNEX LIMITED.
2. Upon registration, you are deemed to comply with the rules otherwise will be ineligible.
3. The **Registration period** for this Contest is open from **08 May 2023, 00:00 till 09 June 2023, 23:55 (GTM+8)**.
4. The **Contest period** for this Contest is open from **22 May 2023, 00:00 till 09 June 2023, 23:55 (GTM+8)**.
5. You are **NOT** allowed to withdraw during the contest.
6. This Contest is open to all entrants who:
 - a) are 18 years of age or above;
 - b) deem to comply with these terms and conditions; and
 - c) are not management, employees, or Promoter agents or its related entities (or immediate family members of such people) (“Eligible Entrant”)
7. To enter the Contest, Eligible Entrants **must**
 - a) Open a new Lirunex live trading account. (“Competition Account”)

Formula:

$$\text{ROI \%} : (\text{Total Profit} / (\text{Invested Fund} + \text{Total Deposits}) \times 100\%$$
